COVID-19 FAQ

Q: What is COVID-19?

COVID-19 is the infectious disease caused by the new coronavirus that first emerged in Wuhan, China, in December 2019.

For more information on symptoms, transmission/spreading of the disease, at-risk populations and much more, <u>please visit this page</u>.

Q: I've seen a lot of information about the disease that has turned out to be false, where can I go for accurate information?

A: This is a fast-moving disease and researchers are trying to quickly learn more about the virus to provide guidance to the public. The WHO has set up a "Myth Busters" page to dispel some of the common misinformation that is being spread. <u>Please visit this page</u>.

Q: Can you provide any assurance that the packages will be coronavirus-free?

A: The <u>Centers for Disease Control</u> and Prevention and the <u>Public Health Agency of Canada</u> have publicly stated that coronaviruses cannot survive the length of time it takes to deliver a package by mail, and new research indicates that the virus will <u>not last more than 24-hours on cardboard</u> in which medications are shipped. The risk of spread from products shipped over a period of days or weeks at room temperature is very low.

Q: Will there be any delays getting my prescriptions?

A: Currently, travel restrictions and the cancellation of flights is impacting delivery times but we understand that orders are being delivered. If you are concerned about delays in deliveries, please contact your online pharmacy directly. This is still a changing situation and we will monitor closely and update these FAQs as appropriate.
