The Big Pharma special interests supporting the DRUGS Act claim that the bill would address illegal sales of opioids online; however, the bill fails to even mention the words opioids or fentanyl. Instead, the bill targets 'non-domestic' pharmacies - international pharmacies that millions of Americans depend on for safe and affordable drugs. If enacted, the bill will terminate access to the websites that millions have used to access their safe meds. Dead links and warning messages from U.S. authorities will replace web access to trusted online international pharmacies.

The Big Pharma groups backing the DRUGS Act habitually and shamelessly exploit the opioid crisis to attack prescription importation. What is most appalling, one endorser took \$1 million from Purdue Pharma, the maker of the highly addictive opioid painkiller OxyContin. We need your help to stop them.
